# 1 Previous Minutes

The minutes of the previous meeting were accepted by all, after agreed amendments.

### 2 Matters Arising

Rotary Club – Presentation by AC and Alan Rankin – 11 February – AC reported that the visit went well. The BID was well received and there was particular interest in the progress of the Paths Group.

#### 3 Admission of New Members

Two new applications for full membership have been received and approved.

#### 4 Treasurer's Report

HG circulated the updated accounts in advance of the meeting. Total funds stand at £8,520 of which £2,020 is unrestricted. AR added that she had arranged another bag pack at the Co-op for Saturday 26 September.

#### 5 Project Updates

Marketing (EH) – circulated by EH in advance of the meeting – website to go live in early March.

**Paths (DG)** – **Trowan to Comrie:** the feasibility study is nearly complete. It is hoped that PKC's consultant, Guy Wedderburn, will be able to meet with the landowners between Trowan and Comrie in March to discuss the findings of the feasibility study and to begin the process of negotiating Path Agreements. PKC has asked us to contact all our local elected representatives (Community Councils, PKC Councillors, MSPs and MP) to request letters of support for the path. DG to action. Funding from Scottish Natural Heritage of £8,250 has been approved.

**Acorn Dell:** applications for funding have been submitted to the SSE Sustainable Development Fund (£12,700) and to PKC's Community Environment Challenge Fund (£8,800) to undertake stage 1 of the Acorn Dell path repair project. The next step is to identify funding for the Management Plan. It was agreed to defer the decision on this.

**Town Centre (AC)** – the Town Centre group had agreed at the last meeting to put the Drummond Arms on a watching brief and in the meantime, the Townscape Study, identifying empty and derelict buildings, would be updated.

AC, Barry Hargrave, Jean Ann Scott Miller (CCC) and John Champion (CUSP) are attending a meeting at Pullar House on 20 February with PKC and 7N Architects to discuss a charrette that has been arranged by PKC and the Scottish Government for Crieff in April and May.

**Transport (RB)** - circulated by RB in advance of the meeting. The new timetable on the Town Bus Service has been in operation for four weeks. RB will view progress and gauge opinion in March.

DG will check with John Champion, and if he is in agreement, she will draft a short online survey for the CCT membership.
