5 Group Reports

Town Centre (AC) (I) **Drummond Arms:** A meeting to be set up with the owners as soon as possible. (II) **Old St Michaels.** Peter Littwin was disappointed with the report on the Old St Michaels Hall. He felt that it would inhibit fundraising from funders. He has been in discussion with Logos and the Parish church about their plans for a Family Hub. They are interested in using Old St Michaels to test out their ideas. The legal issue appears to be that if the Friends of St Michaels establish a year in possession they can apply for legal title.

(III) **Co-working space**. The area below the Strathearn ArtSpace, to be called 'The Lodge Street Annex' was considered to be the best option for testing this idea. The group discussed various ideas on funding, staffing and use of space. Both the Fumbally Exchange and the Melting Pot were asked to quote to assist in the planning. The Melting Pot was £5,000 plus VAT and expenses, the Fumbally £1,500.
