- 1. Previous minutes agreed and accepted.
- 2. Matters arising BB drafted the 'Politicians and Political Party Policy' statement. Salient points highlighted. The draft document will be emailed to be discussed and agreed at January Meeting.
- 3. Declaration of conflict of interest: None
- 4. Membership
 - a. Admission of new members one local member accepted
 - b. Membership renewals ongoing
 - c. Membership Protocol revision in progress
- 5. Action / Strategy Planning
 - a. Big Lottery Funding next steps AC, BB and MM met with Victoria Pearce(VP) from Community Enterprise, LEADER and BL to discuss funding process and match funding. VP will assist with LEADER completion. Three quotes required for each cost to demonstrate due diligence. Application needs submission ASAP as final decisions confirmed in January. Board members will be contacted via email to assist in obtaining quotes. Steering group meets this week to finalise space design, decor and requirements.
 - b. Development Officer hiring process. Job posting live, application deadline 29 November. Agreed AC will sent reminder email to those who have sent in queries. Interviews to be scheduled after Dec 5th. Three Board members to take part at interviews – Goal remains to have position filled by mid January.
 - c. CAP Renewal Plan Meeting was held November 13, Pavilion, MacRosty Park. AC, JA, CS, GM and BB attended. Well attended with BID, Community Council, LOGOS and Church Group present. Mick Doyle will do summary to be circulated and follow up meetings announced. JA noted that CAP renewal needs to conform to National Standards and include 'empowerment' emphasis to comply with new government initiatives and legislation. Renewal will progress into new year with view to complete Autumn 2018.

 - a. Town Centre i) Drummond Arms ongoing agreed next steps to be drafted to assist with discussions
 - ii) Coworking Space ongoing see above
 - iii) Old St Michaels plan completed for accessible paths. Quotes obtained all over proposed budget. IC will assist in further quotes. Exterior works on going with more of yard cleared and planting taken place.
 - b. Paths i) TBW Tree removed from burn and sign to be replaced by contractors at no charge. Tree survey quotes being obtained so as to add to Management Plan.
 - ii) CPG Successful work party on 28/10 with 151 path users noted during session. Questionaire to be sent out by CS Ranger to try to increase volunteer base and possibly work party frequency.
 - iii) Town Centre sign relocation agreed sign to be retained and moved to area near toilets. JA indicated council has funds to complete this work
 - iv) Core Paths PKC in discussions to finalise preferred route CCT commented on draft and update on progress will follow.
