# 5. Treasurer's Report

A Financial Summary was circulated before the meeting. MM highlighted that unrestricted funds are very low and recommended a fundraiser e.g. quiz night at The Meadows. Agreed to ask RM to organize. BB to approach Stephen Leckie at Crieff Hydro to ask him to donate a raffle prize.

### 6. Funding Update

#### 9. Old St Michael's

8<sup>th</sup> October – PL showed Andrew Rodger round. Andrew told PL Museum Group are interested in site. PL sent Andrew the previous survey and advised him that FOOSM believe they are in a position to take ownership of the site as a result of occupation.

10<sup>th</sup> October – Museum Group Board visited for a closer look. Andrew has now requested further access to survey roof, sub floor and tower. PL will facilitate.

PL has advised Museum Group that FOOSM are open to ideas for the building that include community use and/or benefit to Crieff. PL proposed a partnership of FOOSM, Museum Group and CCT. CCT Board agreed that this would make sense and that a museum could be a good use of the building. PL to report to next meeting of FOOSM that CCT are interested in exploring the possibility of a partnership.
