- Gannochy funding £15,000 towards development manager salary costs for a year, now conditions have been met, money has been paid into our account.
- Garfield Weston Foundation for help with core costs. £5,000 unlimited funding for a year. Must report back by 12.1.23.
- Paths for All IFPF for design of link path successful £24,474 accepted and contract awarded to TP&E
- Submitted application to The Fore's next funding round for £27,000 over 3 years.
- £1900 from PKC 'Open for Business' for matched funding to improve external look of 'wee shop'. Extended to end Sept. Claim once spent.
- Fountain PKC CECF accepted £10,000 for fountain refurb.

Oakbank to MacRosty Park Link Path

Following the start up meeting on 11 May 2023 TP&;E have commenced work on the design of the Active Travel Link Path between the housing community at Oakbank and MacRosty Park.

On 22 May 2023 CCT received a copy of the signed disposition from Sir Brian and Lady Elizabeth Souter dated 3 May 2023 disponing to and in favour of CCT the two areas of land coloured pink on the maps. Our solicitor has been thanked (flowers sent to her London office) and we await registration of the transfer.

24 May 2023 our insurers, Keegan Pennykid, were advised that CCT now own the rail embankment and cutting at TBW and were instructed to modify our policy to include cover for it. No response as yet but they are aware and dealing with it (t'call JAA /Shirleen Shand).

Turretbank Wood [TBW]

Meeting on site 25 May attended by Clive Duncan and John Townshend [Scottish Water/Caledonia] and two of their contractors and JAA and R Bone to discuss shortcomings in how they have carried out the landscaping work at the two raised manholes. Undertakings were given by Clive and John but now Scottish Water's contractor has left site without completing the landscaping around the two raised manholes Clive has written to CCT(7 Jun. '23) confirming they are committed to completing the work and provided Peter Crichton's details. He is the Scottish Water Estates Manager and will arrange completion.

This year's campaign to tackle the Himalayan Balsam at TBW has been slow to start because there is very little sign of HB so far. It may be that for whatever reason it is later or (as I hope) we are finally winning. In earlier years school children assisted us before their holidays – I have found 5 stalks so far this year – yes just 5.

A team of 15 volunteers from the 7 th Day Adventists offered to help clearing HB but the prospective dates of 17 th and 24 th June have been canceled because there is nothing to be done at this time. They are at a Camporee in Hungary in July so I have asked them to reserve some time in August in case it is just late this year.

Coop funded Bench – Bench to be purchased for siting in Meadow 2 – Action outstanding but now awaiting design input from TP&E to make sure new location works in their new design.

Crieff Paths Group

The scheduled activity on the Knock on 27 May was canceled due to lack of support. PKC's Countryside Ranger has reminded CCT that there is a small grant of £1000.00 for CCT this year (we traded last year's grant to assist another area). So discussion topic at the monthly meeting -ideas required – what are we short of for the paths activities?

7. Drummond Arms

1. Building update

After much coming and going, scaffolding is now being erected on the high street façade. Now acting as stand alone, not tied into internal scaffold as this would have involved breaking windows and the difficulty assessing the load impact on the internal scaffold tower. There is a substantial angled upstand to protect the pavement and bus shelter from any potential debris fall over the period the scaffolding is there.

Latest costing details from our QS's have offered a series of costings dependant on the outcome, e.g., demolition, façade retention, complete building retained. At this stage the costs favour retaining the High St and Hill St facades, with the roof removed. This offers the developer a blank canvas to rebuild behind and is within their design scope.

A Risk Register is being developed by DARL to reinforce the decisions that have and will be made in the future, covering the following topics:

- 1. Safety and Integrity
- 2. Financial Capability
- 3. Regeneration Objective
- 4. Stakeholder Support
- 5. Board Liability

CCT have submitted a CLLD bid for the cost of the DARL Development Coordinator role for 2023/24,. Still awaiting a decision.

DARL is in the process of submitting a Stage 1 Application to the Low Carbon Vacant and Derelict Land Investment Programme. If successful this would provide capital funding towards repairing the fabric of the building.
